# RENEW GIFT DAYS BIG VISION

To equip and resource St Mary's for a new season:

## 1. Revitalising Cafe Hope and renew mid-week mission

We will soon need to replace the coffee machine, which is a significant expense, but vital to the Café. We are also considering improving furnishings and repairs to the kitchen area. Plus, a new welcome area in church with better communication so visitors can discover the gospel and find out about the life of the church.



## 2. Engaging in online outreach and digital discipleship

This is a new area for us and we need some finance to enable video production for online outreach, particularly at Easter and Christmas, as well as for discipleship resources such as Leading Together, online training and more.



## 3. Investing in our children and youth



We believe it is time to increase our support for our children and youth. To support the rebuilding of our ignite volunteer team, we will recruit an additional part-time staff member for outreach and discipleship among our children and youth.

## 4. Resourcing a culture of prayer

With a renewed emphasis on prayer, we want to professionally publish a daily Prayer Guide for people to use at home. Our heart is to offer helpful resources to deepen our prayer lives.

## 5. Remembering our story and giving thanks

At the appropriate time, we hope to purchase some kind of memorial to remember those in our church and community who passed away or were affected by the pandemic.

## 6. Improving our experience of church

There are a number of key upgrades we need to make to our PA system that will improve the quality of sound at the back of church. It is important that everyone is able to join in fully.

## 7. Upgrading our buildings for mission and hospitality

Our buildings are part of our mission and hospitality. We use them all through the week. Good maintenance is part of our mission. We want to offer a good welcome to people. There are some essential upgrades needed to the flooring in our toilets, lighting in the parish centre and we plan to upgrade our public noticeboards to improve our welcome and communication.

### Further general information

- We want everything to flow from the vision of seeing people follow Jesus and grow in Him. These seven areas form a whole package of investing in people, mission, discipleship and our buildings, as we emerge from the pandemic.
- We would encourage church members who are able to consider setting up or increasing their Standing Order and to give with Gift Aid please.
- Some of the giving will enable us to open new budget lines that will be spent gradually. For example, finance for online mission and discipleship. Also, some items will not be purchased immediately, but at the right time for the ministries. Also, that if we raise less then we will need to prioritise what is spent, and if more is given then it will go towards our general funds. Many thanks.
