#### **Build on the vision for the Hope Centre**

Now in 2023, it is about living out that vision to deliver life-changing ministry and building hope in people lives. This is happening right now and needs generous financial support. We built a building then; now we are bringing the hope of Jesus to our community. This is what we are asking for your financial support for. God is our Provider! He has always been faithful!

#### Keep St Mary's open and active in mission & ministry

















Over 4,000 people come through St Mary's every month! Our doors are open to everyone! We distribute food, offer community, share with those in need, pray with people, gather children and youth, share meals together, study the Bible together, teach the Christian faith, worship and pray, feed the hungry, care for creation, run courses to train and equip people to serve others... and much more!

Our church exists to encounter God, share Jesus, love deeply and live for the Kingdom! We are all about Jesus and bringing His good news to everyone we meet.

#### Fully meet the everyday costs of being open

The church is the people and people are at the heart of our ministry. God has also blessed us with amazing facilities and an excellent staff team to enable so much to happen. This means we have expenses such as paying salaries and costs for our staff, maintaining buildings (utilities, repairs, insurance, servicing etc). We also support mission elsewhere in the UK and overseas. Other costs include cleaning, administration, publicity and Diocesan support. These everyday costs are part of what it means for us to reach out to people.

We are mindful that all our circumstances are different and there is a cost of living crisis which is very real for so many, so if you are in financial need right now, please feel free to let this pass by. We want you to be free to give or not to give to these Gift Days.

### **Giving Goal**
